Our Aim: To support the work of Emmaus House.

Our Mission: To resource people for life, through an integrated approach to an authentic spirituality. Whilst we are based within the Catholic/Christian tradition we aim to provide a safe place for those who are searching for God and/or meaning in their life.

We will support the work by donations, which will be passed to Emmaus House without deduction, so that full use can be made of the Gift Aid Scheme. This scheme enables the donation to be enlarged by additional funds from the government where the donor is a UK taxpayer. Friends of Emmaus House are run entirely independently of Emmaus House. All donations will be used for approved capital expenditure.

For an annual donation of £25 or a monthly donation of £2.50 you will receive:

- A free bottle of house wine when a meal is taken in the restaurant

For an annual donation of £50 or a monthly donation of £5 you will receive:

- A £10 voucher towards the cost of a meal in the restaurant

For an annual donation of £100 or a monthly donation of £10 you will receive:

- A £20 voucher towards the cost of a meal in the restaurant

Each Friend will also receive a personal invitation to social events organised at Emmaus House.

If you are a tax-payer, it is an advantage to Emmaus House if you can GIFT-AID your donation - on top of every £1 you give we will receive 28p from Her Majesty's Revenue and Customs.
